Personal data we process

Fischcon processes your personal data when you use our services and/or when you fill in our contact form on our website and/or provide it to us yourself. Below you will find an overview of the personal data we process:

1. First name and surname
2. Telephone number
3. E-mail address

For what purpose and on what basis we process personal data

Fischcon processes your personal data for the following purposes:

1. To call you or send you an e-mail, if this is necessary for the execution of our services.
2. Delivery and invoicing of our products, in execution of your request
3. To inform you about changes in our services

Disclosure of personal data to third parties

Fischcon will only share your personal information with third parties if this is necessary to perform our agreement with you or to comply with a legal obligation.

How long we keep personal data

Fischcon does not keep your personal data longer than is strictly necessary to achieve the purposes for which your data was collected and to be able to fulfill tax obligations.

All our quotations, all orders given to us and sales contracts entered into, are subject to the Metaalunie Conditions or Orgalime Conditions, were applicable, deposited at the office of the Clerk of the District Court in Rotterdam. A copy of these conditions will be provided upon request.

Access, correction or deletion of data

You have the right to access, correct or delete your personal data. You also have the right to object to the processing of your personal data by Fischcon and you have the right to data portability. This means that you can submit a request to us to send the personal data that we have in your computer file to you or to another organization that you have designated. You may send a request for access, rectification, deletion, or transfer of your personal data, or object to the processing of your personal data, to info@fischcon.com, for the attention of the Data Protection Officer.

To ensure that the request for access has been made by you, we ask you to send a copy of your ID along with the request.

On this copy, black out your passport photo, MRZ (machine readable zone, the strip of numbers at the bottom of your passport), passport number, and citizen service number (BSN). This is to protect your privacy.

We will respond to your request as soon as possible, but within four weeks. Fischcon would also like to point out that you have the option of lodging a complaint with the national supervisory authority, the Dutch Data Protection Authority.
